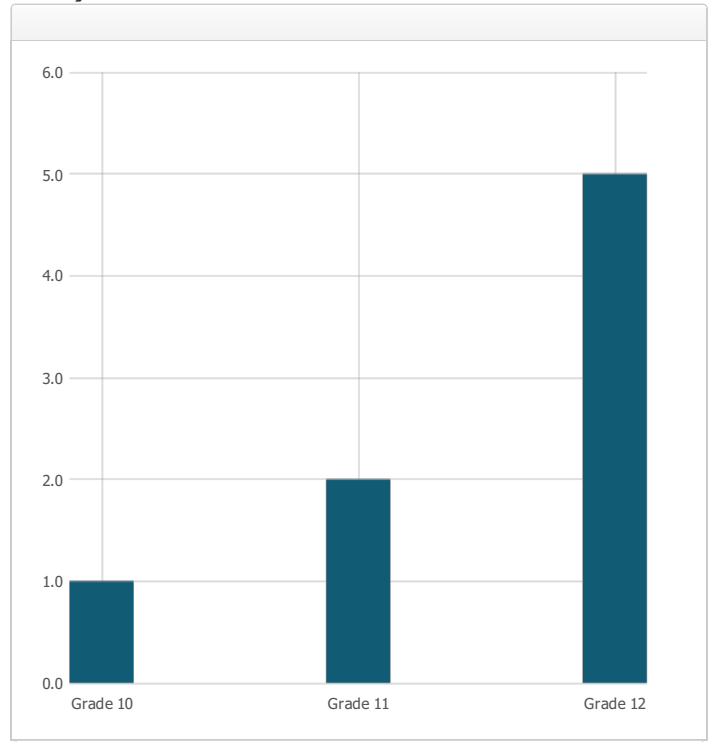
School Description and Mission Statement (School Year 2018—19)

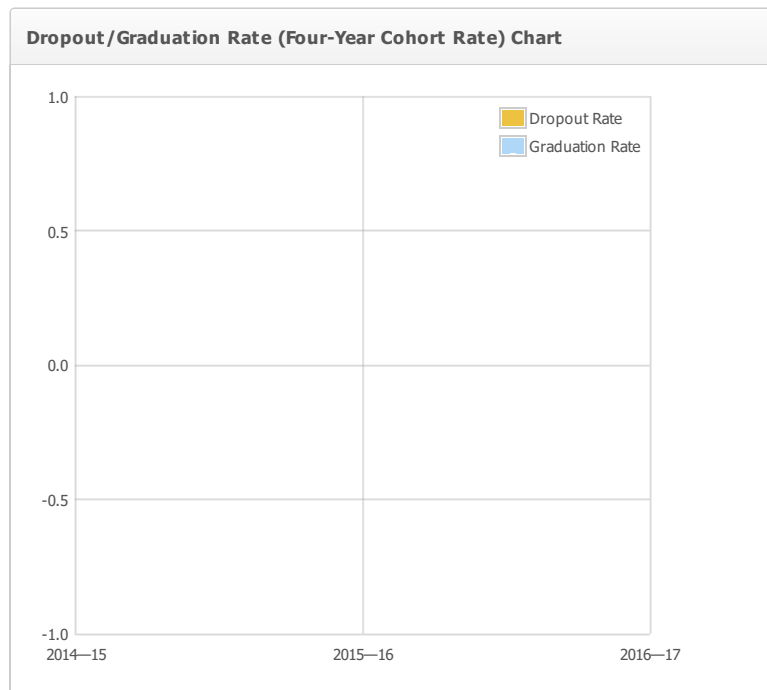

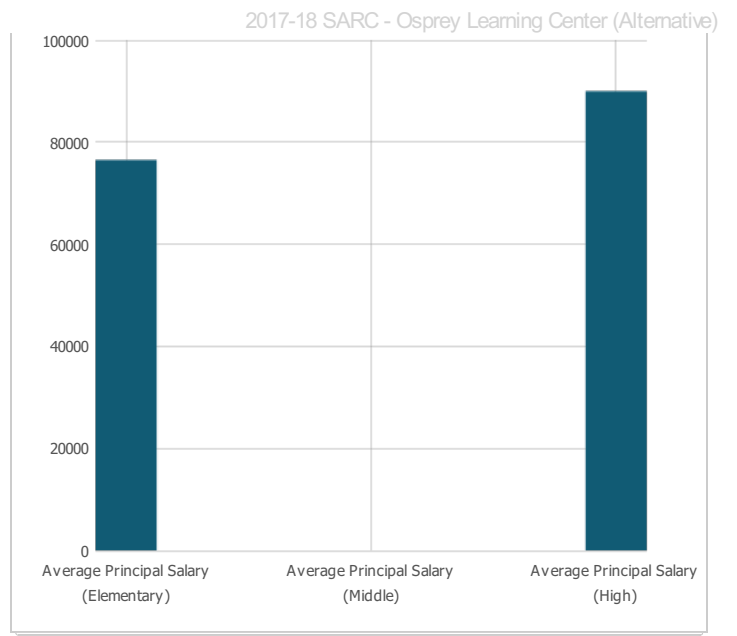
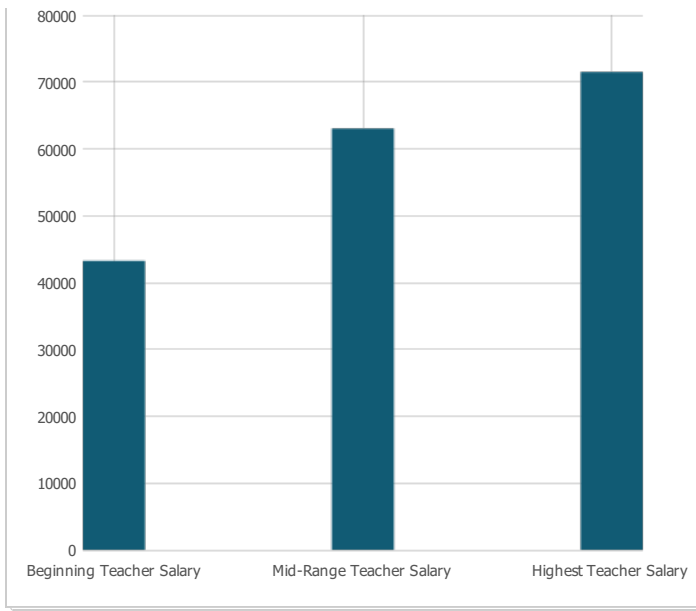
